## Clarification of Pastoral Protocols

Summer Excitement is a ministry of the Quaker Avenue Church of Christ, hosted on the Lubbock Christian University campus, that provides caring relationships in which to share openly and grow in one's faith and spiritual walk with Jesus. Trust given to the staff and volunteer leaders by both *students and parents* is not taken lightly.

At times students may share burdens or important information about their lives. If issues relevant to physical safety or a matter that is particularly critical to a student's social/emotional development is disclosed to a SE leader, necessary information may be shared with parents by Quaker Avenue Church of Christ ministry staff or by Summer Excitement volunteer counselors. Likewise, if a minor discloses plans of self-harm, or if indications exist of an abusive situation in their lives, Quaker staff and any licensed professional counselors volunteering at Summer Excitement are required as mandatory reporters (according to state laws) to share this information with appropriate authorities.

## Minor Participation Authorization and Consent to Emergency Medical Treatment Form

I recognize that there are risks involved in participating in this activity and I hereby assume all risk  
of injury, harm, damage, or death to my minor child in connection with his/her participation in  
this activity.

To the fullest extent permitted by law, I release **Summer Excitement, Quaker Avenue Church  
of Christ, Lubbock Christian University**, its trustees, officers, directors, employees, agents and  
representatives from any injury, harm, damage or death which may occur to my minor child while  
participating in the activity and agree to save and hold harmless **Summer Excitement, Quaker  
Avenue Church of Christ, and Lubbock Christian University**, its trustees, officers, directors,  
employees, agents and representatives from any claims arising out of my minor child's  
participation in the activity.

Further, being the parent or legal guardian of the minor child, I do consent to any medical, surgical,  
x-ray, anesthetic, or dental treatment that may be deemed necessary for my minor child. I  
understand that efforts will be made to contact me prior to treatment, but in the event I cannot be  
reached in an emergency, I give permission to the Summer Excitement Assistant Director to make  
the decisions necessary for treatment. Should the Summer Excitement Assistant Director not be  
available, I give permission to the attending nursing staff or physician to treat my minor child. As  
parent or legal guardian, I understand that I am responsible for the health care decisions of my  
minor child and agree that my insurance plan is the primary plan to pay for the medical, dental, or  
hospital care or treatment that is given to my minor child. Any insurance policy of the church or  
organization sponsoring this event will be used as the secondary coverage.
